PROGRAM INSTRUCTORS:

Annemarie Kammann, PT, Med, recently retired from the Physical Therapy Program at the University of Michigan-Flint where she was the director of Clinical Education. She continues to be active in the MPTA as a member of the Nominating Committee and a trustee for the MPTA Institute for Research and Education. She has been a trainer for the APTA Clinical Instructor Credentialing Course since 2005. Annemarie received her Bachelor of Science in physical therapy from the University of Michigan and her master's degree in health education from Wayne State University. She has experience as a staff and supervising physical therapist, clinical instructor, clinical manager and instructor for both pediatric and clinical education courses.

Martha Schiller, PT, DPT, MSA, is the director of Clinical Education for the Physical Therapy Program at Wayne State University. She has held many positions in the clinical and academic environments, including physical therapist, CI, CCCE, team leader, supervisor and director. She has been a trainer for the APTA-credentialed Clinical Instructor Program for more than 15 years. Martha graduated from the University of Western Ontario with a Bachelor of Science in physical therapy (1986), Central Michigan University with a Master of Science in administration (1993) and the University of St. Augustine with a DPT (2007).

COURSE OVERVIEW

This voluntary program is designed for licensed physical therapists who are APTA-credentialed clinical instructors, and have supervised and mentored at least one student.

The Advanced CCIP brings two constructs together in one professional development program that advances clinical teaching and best practice when providing student clinical education. Using a case-based and interactive approach to education, this program will provide participants with the essential knowledge and skills to more effectively teach and mentor students in the context of a doctoring profession, across core areas of contemporary professional education and clinical practice that foster best clinical teaching and best practice in patient/client management.

The program's unique philosophy and design will enable clinical educators to achieve the best outcomes for student learning by concurrently advancing concepts of clinical teaching and clinical practice.

The program is divided into three distinct parts:

- Pre-course assignments that include reading three articles and completing three online professionalism modules.
- 2. Advanced clinical instructor education via an interactive didactic course format.
- 3. Assessment of curricular outcomes through an Assessment Center.

These components are used together to provide and assess the knowledge and skill identified as essential for Advanced CIs. This voluntary program is designed for physical therapists and physical therapist assistants who have supervised or overseen the supervision of at least one student in clinical practice, or have been actively involved in student learning and education since receiving the APTA CCIP Level 1 credential. The CCIP Level 2 applies and goes beyond the concepts of the structured and effective learning environment from CCIP Level 1 to allow participants to further develop their clinical teaching skills and construct a clinical curriculum. Program participants must complete prerequisites, including completion of a CCIP Level 2 Participant Dossier, a series of three online professionalism modules and review of four articles, in addition to completing a live two-day program with an assessment component.

COURSE OBJECTIVES:

After CCIP Level 2 training, the participant will be able to:

- Discuss the benefits and key components of a clinical curriculum
- Advance clinical teaching concepts learned in CCIP Level 1 as applied to the novice-mastery clinical practice continuum
- Integrate professionalism in a clinical curriculum that promotes the guiding principles to achieve the Vision for the Physical Therapy Profession and the core values
- Diagnose and foster a student's clinical reasoning
- Outline a clinical curriculum to provide key learning experiences critical to patient and client management in the student's practice upon graduation and licensure
- Integrate interprofessional education and collaborative practice into a clinical curriculum
- Integrate advocacy into a clinical curriculum

CONTINUING EDUCATION CREDITS/UNITS:

Successful completion of the course provides credentialed CIs with 1.7 CEUs and the APTA CCIP Level 2 credential. Clinicians from other health care professions who complete CCIP Level 2 are eligible to receive 1.3 CEUs, but would not be awarded the Level 2 CI Credential.*

*Please note: Licensees should verify with their state licensing board for acceptance of continuing education units by reviewing the relevant state practice act and/or administrative code.

PROGRAM ELIGIBILITY CRITERIA

Requirements to register for the Advanced CCIP:

- Current PT license
- Earned APTA Credential CI
- Have mentored, supervised and instructed at least one student
- Clinical competence in providing physical therapy services in accordance with state laws and regulations, as authorized and attested to by the individual's direct supervisor
- Completion of the Advanced Participant Dossier
