## **Overview**

Rehabilitation professionals are continually exploring ways to enhance treatment to improve patient outcomes. The 2019 Stroke Symposium will explore the impact of neuroplasticity and intensity of treatment on rehabilitation after stroke or brain injury, executive function skills following CVA and ways to incorporate the life participation approach to aphasia management into their practice. Rehabilitation specialists will gain knowledge on the importance of increasing activity and intensity of treatment post stroke in physical, occupational and speech therapy, as well as interdisciplinary team approaches. Participants also will gain an understanding of the ways community health workers connect to community resources to address the social determinants to improve health outcomes. All members of the health care team will benefit from the concluding discussions on motivational interviewing, management strategies for compassion fatigue and a patient's experience through the continuum of care.
