OVERVIEW

Patients who have undergone amputation or were born with a limb deficiency experience a unique, lifelong journey that includes managing mobility, prosthetics, skin issues, pain and other adjustments. The 2020 Mary Free Bed Rehabilitation Hospital Limb Loss Conference will provide evidence-based knowledge and experience on these topics presented by experts in the continuum of inpatient to outpatient care at Mary Free Bed Rehabilitation Hospital. Presentations will include a patient's limb-loss journey, in-depth information for identifying appropriate candidates for prosthetics, techniques for dressing and teaching range of motion, pain management strategies using Graded Motor Imagery, utilizing the C-leg microprocessor for greater mobility and freedom, and justifying the K0005 manual wheelchair. Prosthetic care management across the continuum, identifying gait abnormalities and strategies for using EMG on upper-limb amputees will also be discussed. All members of the health care team will benefit from the concluding discussions on nicotine cessation and motivational interviewing strategies.

OUTCOMES

Conference participants will be able to identify and discuss appropriate candidates for prosthetics, techniques for dressing and teaching range of motion and pain management strategies using Graded Motor Imagery. They will obtain a thorough understanding of utilizing microprocessors, justification of a K0005 manual wheelchair and prosthetic care management across the continuum, as well strategies for using EMG in upper-limb amputees and identifying gait abnormalities. Attendees will gain a greater understanding of the patient's journey after limb loss and the challenges and adjustments they face. They will be able to discuss utilizing a team approach to nicotine cessation and motivational interviewing strategies.
