## Overview

The 35th annual WMBIN symposium provides an overview of current practice guidelines and treatment strategies for people with acquired brain injury in interdisciplinary rehabilitation, from acute management through extended social, psychiatric and functional adjustment to community settings with an emphasis on effective and validated interventions.

## Target Audience

## Outcomes

Those in attendance will be able to describe the various professional perspectives of caring for those with a brain injury and management strategies to provide the best outcomes through panel presentations and discussion.

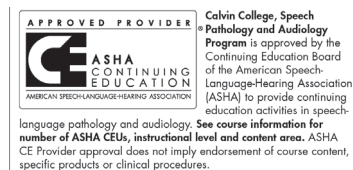
